Your loan payment amount will remain the same, but skipping a payment may extend the term of your loan. Finance charges will continue to accrue on all new and existing balances during the skipped payment period (December 1 through December 31, 2024) pursuant to agreements with the Credit Union, and all terms and conditions will apply after said skipped payment period. **Important note about skipping auto loan payments:** If you purchased GAP coverage through an auto dealer (not through the credit union), please review your policy to ensure the permissibility of skipping payments. In some instances, skipping payments may impact GAP coverage.
